



Frequently Asked Questions

Does it hurt?

Laser aesthetics are uncomfortable; the discomfort level varies based on the person.

Tattoo removal treatments only take 10-15 minutes; Laser treatments only take 10-15 minutes, and you can expect a zap to the skin that is warm to hot, and after the treatment, the skin will feel equivalent to a sunburn.

Can I be on medication?

No photosensitive medications. If taking daily medication(s) check with your physician prior to receiving laser. Please see our medication list of photosensitive medications.

What is the price point for tattoo removal, laser aesthetics, and chemical peels?

Tattoo Removal prices range between \$100 and \$500 per treatment, and most will require more than one treatment. A series of 2-6 treatments is needed for the best results, depending on the age, color, and material of the ink.

Can I swim or shower after treatment?

Yes, wait at least 24 hours after treatment. Swim indoors for the first 3 days and avoid direct sun exposure and hot water on the treated area. Wait 24 hours to take hot showers or use hot tubs.

Can I be pregnant?

No.

Can I be breastfeeding?

No, talk with your primary physician about your concerns prior to receiving treatment.

Can I be on my period?

Yes.



Will I see results immediately?

Patience pays off when transforming the skin with tattoo removal. These treatments can require a series to get the best results. Before and after care maintenance is required for best results, and changes vary from person to person.

Tattoo removal treatments can be scheduled and performed every 6 to 12 weeks, depending on skin type and the number of treatments, depending on the color, material, and kind of ink used in the tattoo. Laser treatments can be scheduled and performed every 6 to 12 weeks. The number of treatments depends on skin type and the skin condition, texture, ink material, and area being treated.

Can I go to the gym?

Yes, but wait 24 hours; the heat from the laser stays in the skin for 24 hours.

Can I tan or be outdoors in the sun?

Wait at least 72 hours after your last treatment for artificial tanning. Outdoor tanning cannot be done while receiving laser treatment or during the treatment process, and when outside, always wear sunblock and/or cover the treated area to avoid direct sun exposure. If tanned, you must wait until it fades before starting treatment.

How many treatments will it take?

Tattoo removal results vary based on the type, texture, ink material, and condition of the skin. For the best results, a series of 3–6 treatments is recommended, and before and after care treatment needs to be followed.

Can laser skin care help with ingrown hairs?

Yes, helps reduce ingrown hairs and bumps.



Can I use my skin care products after treatment?

Scrubs, glycolic acid, and retinol creams should be avoided at least 2 days before and after treatment. Avoid chemical peels, and similarly, you should wait 1 - 2 weeks before using a fake tan.

Can I tweeze or wax after treatment?

No, this impedes the process. Please shave instead.

Can I have implants?

Yes, the laser will not impact your implant.

How long until I can get a facial or other skin treatment?

Allow 2 weeks for the skin to heal from the tattoo removal treatment before getting other treatments to the area.

Can I get cancer from tattoo removal or laser skin care?

According to the Skin Cancer Foundation, laser tattoo removal and skin care pose no known risk for cancer.
